

JUSTICE the IT Trial System Pursuing Facts to Judge Causes of War._{2025/4/17,19}


There would be no better way to end a war conflict than through negotiation. The basic method is for both sides to compete over the truth of evidence by presenting facts.

Both nation Citizens A and B in the war conflict can freely participate via PC communication, and **juror C from third country** can observe this meeting and exercise their right to vote for each piece of evidence to reach a highly reliable conclusion on the facts.

*Third country national C can also be a witness if both the parties agree.

*A settlement judgment can also be reached by agreement between the two countries.

[2]: Basic Design:

① Procedures for starting a trial

(1) Application of complaint A and formality review

Complaint A's public notice to defendant country B and B's answer acceptance, if there is no public notice, A's victory is decided

(2) **Application of witness evidence and formality review**

A1, A2, A3,.....

B1, B2, B3,.....

(3) Application for jury members, credibility assessment review, and granting of judging vote account. Parties A and B prepare an equal number of IQ tests, similar reasoning ability assessment ability, and political beliefs test questions review.

② Start of trial and progress management

(1) A1 witness statement of evidence and B1 refutation witness statement of evidence

→ $C_1 = (A1\text{-Yes})$ total number of decision votes, $\bar{C}_1 = (A1\text{-No})$ total number of decision votes,.....total number of votes = $C_1 + \bar{C}_1 = C(1)$

(2) A2 witness statement of evidence and B2 refutation witness statement of evidence → C_2 decision vote

(3).....

☞ Problem:

Only at the final judgment time can determine the weighting of each piece of evidence, but at each times of evidence judgment,it is impossible to determine the weighting.

$\langle C \rangle = \{C_1/(C(1) + C_2/C(2) + \dots + C_N/(C(N))\}/N.. .$ weighting-less, → $W_i=1/N$ (equal weight)

$\langle C \rangle = \{W_1C_1/(C(1) + W_1C_2/C(2) + \dots + W_N C_N/(C(N))\}$...weighting judgment,

→ $W_1 + \dots + W_N = 1$. (probabilistic weighting),

③ Conclusion

(1) Conclusion when the verdict counter reaches 90% (9:1)

(2) If the verdict counter is less than 90%, overtime is used to update witness evidence.

[3]: Functional design < toward Fact Revealing Machine!!>

The current author has no specialist knowledge not only on legal matter, but also on the software details, however the following software is required.

(1) A cloud-based service application software that anyone can use, managed by organizations, companies, and national governments, that operate for profit and with donations.
